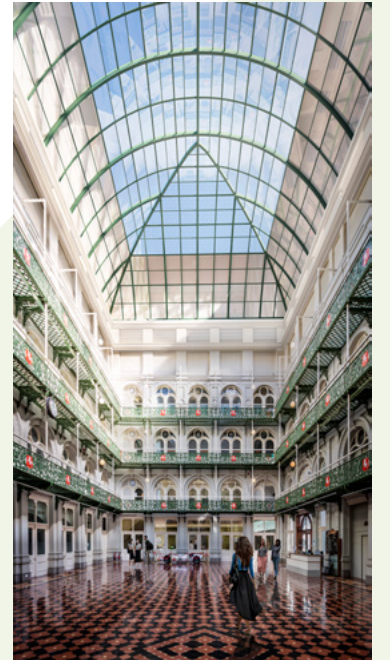
## The Hop Exchange
